# Phase III Draft Plans Released; Water Work Set for August

After a number of schedule changes by the Virginia Department of Transportation, and the intervention of elected officials, the City Park Civic Association has been advised that utility replacement and relocation work for Phase III of the City Park Homes Drainage Improvements project will begin this year.

Around mid-August, the City of Falls Church will begin replacing it water lines in the area, with any needed work by the other utilities to follow in the fall. Roadway, curb and gutter, and storm-drainage work will begin, under a VDoT contract, in March of 1998. VDoT's decision to support an early start of utility work was reported to the CPCA board on July 21, by Delegate Bob Hull, who together with Providence District Supervisor Gerry Connolly has been working with VDoT to expedite the project.

VDoT has furnished the CPCA with a set of preliminary drawings for the Phase III project. Residents wishing to review the drawings, or who have questions about the project, should contact their Block Captains, as listed on page 2. In particular, homeowners who do not have a driveway but would like to have a driveway apron installed at no charge should contact their Block Captains immediately, if they have not already done so. If your zone does not yet have a Block Captain, please call Albert LaFrance on 536-2420 with your questions and, we hope, to volunteer to perform this valuable community service.


